Chairman's Report

Presentation from Michael Magnusson regarding the Revolving Loan Fund, Microenterprise Grant Program, and Empire Zone. M. Magnusson provided a list of businesses with current loans and grants in Madison County. The programs have been very successful, highlighting All Seasonings in Oneida. Mike also provided an overview of the Agricultural Revolving Loan fund, of which about half of the \$100,000 is loaned. These funds provide gap financing to businesses of up to 40% of project costs, and do not replace bank financing. The Empire Zone program currently has 33 companies enrolled in Madison County, Mike monitors and reports on these companies annually.

Update from Albany (George Cregg)- not much is going on in Albany as the legislature is out of session.

Application for IDA financial assistance was presented from PDJ Inc., dba Johnson Brothers Lumber. As a value added agricultural operation, PDJ Inc. is asking the IDA for the 15 year extended PILOT agreement for their project at the Madison County Landfill. Motion authorizing Executive Director to hold a public hearing regarding PDJ, Inc. project by R. Lura, seconded by J. Salka, roll call, approved.

Executive Director's Report

New Business:

- A. International Boxing Hall of Fame land transfer is expected to move forward, will be discussed possibly in March.
- B. The appraisal for the Elm Street Development has been completed; invoices have been issued to the IDA, City of Oneida, National Grid, and Jack Curtin. All have agreed to pay one quarter of the cost, in the amount of \$1400.00, however, National Grid's agreement is for reimbursement of the funds when the land is considered "shovel ready". K. Hicks stated he would like the IDA to pay their portion in order to keep the project moving, and get reimbursed next year. K Hicks stated that he has met with state officials in Albany who have promised to dedicate funds for the infrastructure development on the Elm St. property to the City of Oneida. E. Moran stated that it would be in everyone's best interest to not hold this project up over \$1400.00 and have the IDA pay National Grid's portion in anticipation of reimbursement in the future. Motion to approve payment for appraisal on behalf of National Grid by R. Lura, seconded by J. Romagnoli.
- C. Empire Brewing Company has cleared all local hurdles, construction to begin in Spring 2014.
- D. Growing Upstate Food Hub is working through some environmental issues, has opened a store in Manlius featuring Madison County farmers and food.
- E. K. Hicks attended Senate hearing on manufacturing in New York
