Other Business

Waterfall Designs was a small light manufacturing business in Chittenango with an IDA PILOT Agreement- they have sold their building to CNY Bus Sales in the Town of Sullivan. CNY Bus Sales has requested to continue the PILOT on the property, however the IDA Board decided that the new use would not fit and that the cleanest and best choice would be to terminate the PILOT agreement. Chris Canada from Hodgson-Russ was introduced, he has been handling some details for the Green Empire Farms project.

ARE Park Updates- there is some discussion currently about soil transfer, and some challenges continue with the Town of Lincoln.

The Consolidated Financial Application (CFA) process is closed, Hicks is on the scoring committee, decisions should be announced in December. Cazenovia and Hamilton applied for downtown revitalization grants, but Auburn was this year's recipient.

Rogers' Report

The Village of Morrisville is currently working on a comprehensive plan. There are still funds earmarked from the 2015 Commons II Morrisville project. SUNY Morrisville continues the Opportunity Agenda School in Syracuse, the school teaches GED courses and prepares students for college.

Agricultural Economic Development Updates- Open Farm Day was a success, final numbers not out yet. There have been several changes at CCE.
