Governance Committee- recommendation for approval of PARIS Accomplishments and Goals

Update on Court of Appeals- George Cregg stated that the GFC is allowed to be a subsidiary of the IDA but the GFC will have to file separate PARIS reports.

Executive Director's Report

Old Business: Green Empire Farm-consent of taxing entities- project is under construction and Chris Canada is working with the company on PILOT special assessment wording. The City of Oneida and National Grid are still working through infrastructures issues. There have been many trucks bringing dirt to the site, and some complaints, contractors are working with residents to resolve.

Canastota Windpower- Public hearing minutes were presented. The taxing entities have not reached an agreement on the PILOT, the IDA is not going to approve anything without unanimous consent of each entity. The IDA has not heard anything from the company's attorneys in over a month, and due to the lack of consensus, and availability of the 487 tax program, the IDA votes to deny the application.

Building heating line break- a heating line broke and was repaired, but the system will need some work this year, along with potentially painting the exterior of the building.
