Review of Financials

Executive Director's Report

Old Business: 33 Rippleton-still no guidance from NYS regarding Start-UP NY, we are not expecting the brewery to partner with SUNY Morrisville at this time as Empire did. As it is past the taxable status date, Meiers Creek will continue to receive full property benefits as Empire. This will be revisited by the IDA next year.

The IDA board is sympathetic, however, George Cregg, and Chris Canada agree that it is a slippery slope modifying benefits, and Moran stated that it could involve taxing entities and legal mechanisms and the Board of Directors agreed that this request is not feasible. Lura stated that an alternative to a PILOT agreement with reduced taxes, is full taxes.
