#### **Public Authority's Mission Statement:**

The Madison County Capital Resource Corporation's mission is to establish and implement sound economic development strategies in order to enhance, among others, the economic vitality of not-for-profit corporations and other entities that undertake projects to improve the overall quality of life of the people of this community.

Key to the Agency's mission is the creation and retention of job opportunities, diversification and strengthening of Madison County's economic base, and developing the local economy in a planned, organized, and environmentally compatible manner.

#### **List of Performance Goals:**

- Identify and assist at least 1 entity with financial resources to assist them with investing in capital improvements that result in new, modern, or improved services that have a direct impact on the people of Madison County.
- Enter into contracts for services to allow the Madison County CRC to achieve its goal of carrying out the agency's mission (IDA, MGFC, PCD, CACDA, AED/CCE and others) as needed.
- Continue to work with Colgate University and the Village of Hamilton on infrastructure development for the affordable housing initiative.
- Continue to work with Cazenovia College and the Cazenovia Area Community Development Association to help market and leverage the Caz Arts initiative to maximize its economic impact.
- Prepare to assist SUNY Morrisville and the Village of Morrisville, should a request be made to leverage the CRC's resources on community development, workforce training programs, or other economic development related activities.
- Meet quarterly with the Board Chairman, Planning Committee and representatives from Working Solutions throughout the year and will keep them apprised of our efforts.
- Maintain internal efficiency; all applications for financial assistance will be brought before appropriate boards for consideration no later than 2 months after the receipt of complete applications.
- Promote the resources of the Madison County CRC to the public.
- Complete goals set out for the year ahead as prescribed by the board of directors.
- Financial statements will be audited, resulting in no deficiencies.
- Board members will attend at least 2/3 of the meetings throughout the year.
