#### **Public Authority's Mission Statement:**

The Madison County Capital Resource Corporation's (CRC) mission is to establish and implement sound economic development strategies in order to enhance, among others, the economic vitality of not-for-profit corporations and other entities that undertake projects to improve the overall quality of life of the people of this community.

Key to the Corporation's mission is the creation and retention of job opportunities, diversification and strengthening of Madison County's economic base, and developing the local economy in a planned, organized, and environmentally compatible manner.

#### **List of Performance Goals:**

- Identify and assist at least 1 entity with plans for capital improvements or project financing that results in new, modern, or improved services that have a direct impact on the people of Madison County, or to assist with refinancing existing bonds.
- Enter into contracts for services to allow the Madison County CRC to fulfill its economic development mission: Madison County Industrial Development Agency, Madison Grant Facilitation Corporation, Partnership for Community Development, Cazenovia Area Community Development Association, Agriculture Economic Development/Cornell Cooperative Extension and others as needed.
- Prepare to assist SUNY Morrisville and the Village of Morrisville, should a request be made to leverage the CRC's resources on community development, workforce training programs, or other economic development related activities.
- Meet regularly with the Board Chairman, Planning Committee, and representatives from Working Solutions throughout the year.
- Effectively manage idle cash to maximize the rate of return in bank accounts.
- Maintain internal efficiency; all applications for financial assistance will be brought before appropriate boards for consideration no later than 2 months after receipt of complete applications.
- Promote resources of the Madison County CRC to the public.

- Complete goals set out for the year ahead as prescribed by the CRC Board of Directors.
- Financial statements will be audited, resulting in no deficiencies.
- Board members will attend at least 2/3 of the meetings throughout the year.
